President's Message

Hey! I'm glad you made it through this whirlwind of a year. Between switches from online, hy-flex, and in-person learning, I'm sure we're all feeling some relief to reach the end of this (for now and hopefully for good!). The upcoming year looks bright and optimistic with returns to on-campus learning and events – no more staring at screens for 8+ hours a day!

Despite Covid, this year has been quite successful! On my second day in office, we officially unveiled our new identify as Red Deer Polytechnic. We saw all five degrees come through this year, and saw more go down the chute for approval. We experienced the implementation of our very first Red Deer Polytechnic degree in the BA Psych, with most of the others coming up in Fall 2022. I'm so glad students now have the choice to stay here and learn right from their Central Alberta homes! Not to ignore our International cohort – you guys hold a special place in my heart! We've seen International enrollment grow tremendously, for which I am grateful. Some of the most important lessons I've learned as a student came from my International peers and the unique perspectives and different ways of knowing they bring.

Over the Fall of 2021, we hosted the federal forum here on campus. While it ended early, it was an honour to be a part of that experience and I'm hoping the SA will get another shot in future elections! I joined the Alberta Students' Executive Council as part of their Board of Directors, where I ended up on the Lobby Team and got to talk to our Minister of Advanced Education about matters such as future proofing tuition rates, meaningful consultation around tuition and mandatory non-instructional fees, and supports for International students. Our biggest win with the provincial lobby group was the campus sexual violence policy reform – that is, establishing guidelines for the policies across Alberta to be survivor-centric and trauma-informed. This win has been years in the making! Additionally, I joined the Federal Student Advocacy Alliance this year as one of two Alberta representatives to talk to the federal government about student issues such as the Canada Summer Jobs Program, grant funding for students, and permanent residency pathways for International students.

In terms of institutional advocacy, the SA has been beating the drum to the tune of Open Educational Resources, or OERs. OERs are free educational resources (such as textbooks, videos, and audio files) that could eventually replace textbooks. We developed a proposal for a print-on-demand model and presented it to senior leadership on the basis that we would be the first institution in Alberta to offer print-on-demand. This path is still to be explored, and the SA has made a commitment to the Alberta Students' Executive Council to lead this as a provincial campaign. The SA was also successful in implementing permanent Treaty 6, 7, Metis, and progressive pride flags on campus, which can now be seen above the front entrance. We are also steadily working on developing an Indigenous Student Space on campus. We've also pitched \$20,000 to build a parent room and are looking into redoing the Serenity Room with proper prayer mats and better chairs.

The story of the SA and its wins over the years continues. I have been blessed to a part of its history, and to be elected for one final term. Thank you to the students who have entrusted me with this very important and impactful job. I will continue to do my best to make sure that the student voice is in every room!


OPERATIONS & FINANCE

The 2022/2023 General Election was held between Wednesday, March 16 to Thursday, March 24. We had 1 candidate each for the positions of President, Vice President Academic, and Vice President External and 7 candidates for Student Council. Voting was available online through the student's Loop accounts and was open from 9am on Tuesday, March 22 and 4pm on Thursday, March 24. With a voter turnout of 17%, up 7.1% from the 2021/2022 General Election. In addition to our Executive and Council positions, we asked students to rank advocacy priorities for the upcoming year.

Advocacy

May 4, 2021

Red Deer College announces that they will become a Polytechnic Institution. The Students' Association has been a strong advocate for the growing needs of Central Alberta students. The SA worked with the Institution, government, and students to ensure that students voices were heard at the table during the transition from College to Polytechnic.

June 23, 2021

Red Deer College announces the new name of Red Deer Polytechnic. The Students' Association was very active in the development and rebranding of the Institution.

September 21, 2021

The students gained recognition of their 2016 \$500,000 donation to the Gary W. Harris Canada Winter Games Centre. The SA advocated to ensure that the student's donation was proudly recognized and displayed on the Gary W. Harris bridge.

December 10, 2021

The Students' Association hosted the first Student Bursary Tele-a-thon to raise funds for the Student Emergency Bursary Fund. Students have many financial burdens and the SA continues to advocate for affordability. We proudly collected \$15,000 and an anonymous donor matched all donations which doubled the contributions to \$30,000.

February 18, 2022

Red Deer Polytechnic announced the Bachelor of Education and Business Administration Degrees which has been something the students of RDP have been advocating for over 30 years. The Students' Association is committed to continuing to advocate and work with the institution in the development and implementation of more degrees.

February 15, 2022

The Provincial Government announced a \$2.5 million dollar grant to be provided to post-secondary institutions to support campus sexual violence training and awareness programs. The SA through the Alberta Students Executive Council (ASEC) have been advocating for increased supports to address on campus sexual violence.

Capital Projects

HVAC

Replaced four rooftop units that were over 20 years old to improve air quality in the Students' Association office and Far Side Bar & Grill.

The Loft Signage

Completed the design and assembly of all signage in The Loft, including the signs at the front entrance and for the Council Chambers.

Treaty Map and Progressive Pride Flags

We proudly permanently display the Treaty Map of Alberta and a Progressive Pride Flag in the windows as you enter the Students' Association office. Both can be seen from inside the Executive Lounge, as well.

Security Cameras & Key Fobs

All security cameras and their systems were updated in the Far Side Bar & Grill, The Loft, The Lift, and the SA office. In addition, all the doors inside the SA office, The Loft, and exterior doors were updated to be keyless.


Membership Engagement

In 2021/2022 we experienced many challenges related to COVID-19 regulations and how they impacted in-person events and learning on campus. Regulations changed often and we adapted as best we could.

We were thankful to kick off the year with an in-person welcome event, "Flying Through Your Time at Red Deer Polytechnic." We hosted the Free Breakfast Program, Communitea, and Free Legal Help regularly. In November, we began to offer one-on-one resume help with Career Catalysts once a month. We saw great success and plan to continue this partnership. Other notable events include puppy rooms, pumpkin carving, holiday card crafting, Risque Bingo, free yoga, and guided meditation.



Services



Lockers

In 2021/2022, the Students' Association rented 369 lockers to students. This number is slightly higher than 2020/2021.

Transit

421 Semester Bus Passes were sold to students, which is a significant increase from the previous year. This increase is attributed to more in-person learning.

Student Groups

10 student groups were active; however, frequent changes to campus restrictions were a barrier to all groups.



Services Cont.

CAT Fund

The Cultural Activities Trust Fund (CAT Fund) helps fund cultural events held at Red Deer Polytechnic. Both students and faculty sit on the committee to review and approve subsidy applications. This year, CAT Fund assisted the Agora Conference, Student Science Conference, and the Indigenous Perspective Conference and collectively provided them with \$4, 199.18.

SIP

SIP (Student Initiatives Program) help funds events showcase leadership, help our members grow personally and professionally, and foster new items while promoting change. In 2021/2022 we gave a total of \$1,500 to 5 initiatives.

We assisted the Social Work Student Society with both their Remembering the Children postcards and Socially Conscious Holiday cards, the Science Society host the Student Science Conference, and 2 students attend the Canadian Psychological Association Annual Conference.

Food Bank

Our student-run food bank is one of our busiest services on campus and this year, we saw the highest usage since 2016/2017. While it is difficult to see students struggling with food insecurity, we are thankful that we are able to help. In 2021/2022, our team fed 281 students and their families with 186 food hampers.

We rely on the kindness of donors from the institution as well as the greater Red Deer area. We have numerous food bank cans around campus, donation options available on our website, and accept donations over the phone. We are grateful to have recieved a total of \$4,218.45 in food bank donations.

The Soup Program began in 2019/2020. Each purchase of soup at the Far Side Grill is sold on a "pay-what-you-can" basis, and each dollar spent is put towards our Student Food Bank. This year, the Soup Program donated \$1,957.50 to the Student Food Bank.

We are grateful to those who donated and made a difference to our students.




Businesses
