 - o Final Examination Policy Sub-Committee: Still working on the policy and procedure.
 - o Academic Student Caucus: Good attendance, not much discussion.
 - o Meet and Greet with Risk, Privacy, and Legal Services.
 - Academic Council: Good attendance of students. Most notable mentions include:
 - the addition of INDS 0300 Indigenous Studies "This course was developed in order to provide an additional pathway for students who need more credits in the humanities disciplines in the Academic Upgrading (AU) program. Currently, AU only delivers equivalents of Social Studies 30 and an array of English courses as humanities offerings. Indigenous Studies 0300 will not only provide more scheduling options and opportunities for Academic Upgrading students to reach credit thresholds for high school equivalency and transfer programs, but will also allow students an additional choice that may better align with their interests, experiences, or plans."
 - Multidisciplinary Studies will have minors options starting in Fall 2024: "Adding a mechanism that allows a student to declare a minor in the multidisciplinary degree provides learners with the ability to customize their education so as to permit more intensive focus in an area of their choice. As this set of minors will be the first minors to be added to an existing degree or program at Red Deer Polytechnic, moving these minors forward will serve as a test case for developing minors and concentrations more generally. Disciplinary minors were chosen to enable students to focus their study within a specific

- discipline in the humanities or social sciences while staying true to the multidisciplinary range of the overall degree."
- The suggestion that there should be more online options offered for higher level courses, specifically PSYC 300s.
- Vice President External J. Chilibeck
 - ASEC Budget: Advocate for no student loan interest, increased base funding for mental health on campuses. The Alberta Government's budget will be released on February 29th.
 - Sent an email of events.
 - Looking into opportunities for Council to volunteer with Habitat for Humanity.
- Executive Director E. Sweiger
 - Sat on two RFP Committees with the Institution; one for Food Services and one for Vending services.
 - The plebiscite question asked to students during the General Election was "Should all part-time students be eligible for the extended health and dental benefits? Coverage includes, but is not limited to, prescription drugs, vision, mental health practitioners, etc.(Currently only full-time students are eligible.)". Students were 88.1% in favour of this change.
 - Elections: ED Sweiger offered her congratulations to those who were elected. She hoped that the election was an opportunity for the candidates to not only showcase themselves but also an opportunity to highlight the services and supports the SA offers our students.
 - Waiting on Winter Fees from the Institution. These fees will give us a better idea of where we are sitting for the rest of the year.
 - SA Awards Ceremony: The Awards ceremony will be held the morning of April 16th. Councillors will be receiving invitations and are encouraged to attend.
 - Deadlines for SA awards and scholarships is March 1st. Please be sure to take a few moments to nominate your fellow students for our leadership awards. You can access them through the SA website or the RDP website.
