1.4 Discussion

1.4.1 Indigenous Art Purchase

The president of CUPE has reached out to the Association to gauge our interest in jointly purchasing a piece of Indigenous art by George Littlechild. He is a local to Red Deer and a RDP alumni. The piece would be part of the Polytechnic's

permanent art collection. The piece would have a plaque recognizing the Association's contribution. It would be placed in a highly visible location and would be ideally, on permanent display.

Council has suggested that we look into developing our own budget line or restricted fund for the purpose of purchasing art for our own space.

1.4.2 Executive Work Plans

Traditionally, the newly elected Executives would spend the summer creating a workplan for the year and bring it to Council for approval.

We are looking at changing this process to give Council more input into the development of the workplans. We will be piloting a new process in 2024, wherein Council will begin brainstorming for the 2024-2025 academic year. Council will make a formalized list of priorities by the end of March to inform new executives priorities and allow for continuity in Board direction.

Ideally, the executive workplan would become a living document that provides direction and priorities, while still providing the necessary flexibility to pivot when needed. A progressive living document will allow for better organizational continuity.

1.4.3 Tablets for Council

The 2022-2023 student association council approved a summer 2023 capital budget including \$4000 for the purchase of tablets for the use of council. The cost of these tablets is more than was anticipated, with the inclusion of a case screen protector and protection plan it is looking like it will be about \$500 per tablet. This initiative is part of the association's ongoing commitment to the sustainable development accord and reducing our consumption as an organization.

Council suggested looking at leasing options and suggested that some Councillors would prefer having a paper package over using a tablet at council.

More research into options will be conducted.
